# SEVNA, LLC - Limited Warranty

## Coverage Provided

### Thirty-six (36) Month Limited Warranty

SEVNA, LLC ("SEVNA") warrants that it will repair or replace defects in material or workmanship in any components of a cut-away cab ("Cab") manufactured by SEVNA and purchased from an authorized SEVNA dealer in the United States or directly from SEVNA for 50,000 miles or for a period of thirty-six (36) months from the date the Cab is first delivered to the original retail purchaser, subject to the other terms and conditions of this Limited Warranty.

## Terms and Conditions of Coverage

This Limited Warranty extends solely to the first retail purchaser of the Cab and is not transferable to subsequent owners. SEVNA makes no warranties or representations other than as set forth in this Limited Warranty. In order to obtain coverage under this Limited Warranty, you must notify an authorized SEVNA dealership or SEVNA of the warrantable issue no later than ten (10) days following expiration of this Limited Warranty.

Repair or replacement of defective components is the sole remedy under this Limited Warranty. This Limited Warranty does not extend to future performance of the Cab. SEVNA shall be entitled to condition warranty coverage under the thirty-six (36) month limited warranty on purchaser allowing SEVNA to transport the Cab to its facilities in Elkhart, Indiana for purposes of the repairs. SEVNA reserves the right to use new or remanufactured parts of similar quality and appearance.

No person or entity has authority to alter the terms and conditions of this Limited Warranty, and SEVNA shall not be bound by any representations or warranties of its dealers, or any other person or entity.

## Limitation of Implied Warranties

Implied warranties arising under applicable state laws, if any, including but not limited to implied warranties of merchantability or fitness for a particular purpose, are limited in duration to the applicable term of this Limited Warranty, and are limited in scope of coverage to the scope of coverage under the Limited Warranty. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

## What Is Not Covered by This Limited Warranty

This Limited Warranty does not provide coverage for any of the following:

- 1 The chassis upon which the Cab is installed, including but not limited to the frame, electric motors, and batteries, which are warranted by the respective manufacturer and administered separately from this Limited Warranty;
- 2 Any Cab exported to, primarily used in, or licensed in a country other than the United States and Canada;
- 3 Deterioration or fading due to wear, exposure, or other cause, including but not limited to rust, cosmetic blemishes, and discoloration;
- 4 Any part or component of the Cab that was not manufactured or installed by SEVNA;
- 5 After-market equipment or accessories installed on the Cab after completion by SEVNA, or any defects or damage caused by such items;
- 6 Normal maintenance and service items;
- 7 Cabs not purchased through an authorized dealer of SEVNA or directly from SEVNA;
- 8 Cabs purchased directly or indirectly through auction, salvage, or repossession;
- 9 Defects or damage caused by, in whole or in part, or in any way related to the following:
  - 1 Accidents, misuse (including off-road use), theft, or negligence.
  - 2 Failure to comply with the instructions set forth in any owner's manual provided with the Cab.
  - 3 Alteration or modification of the Cab except such alterations or modifications approved in writing by SEVNA.
  - 4 Acts of God or other environmental conditions, such as lightning, hail, salt, or other chemicals in the atmosphere.
  - 5 Failure to properly maintain or service the Cab, including but not limited to the maintenance of lubricants, sealants, and seals.
  - 6 Condensation and the results of condensation including water damage and the growth of mold or mildew.
  - 7 Use of the Cab other than for commercial purposes.
  - 8 The addition of weight to the Cab that causes the Cab's total weight to exceed applicable Cab weight ratings, or addition of weight causing improper distribution of the weight of the Cab.
  - 9 Failure to seek and obtain repairs in a timely manner.
  - 10 Improper electric power supply or improper Cab hookup to other facilities.
  - 11 Failure to properly ventilate the Cab.
  - 12 De-icing agents or other chemicals applied to the Cab.
  - 13 Acts or omissions of any person or entity other than SEVNA.

## Disclaimer of Incidental and Consequential Damages

SEVNA hereby disclaims any and all incidental and consequential damages arising out of or relating to the Cab, including expenses such as transportation to and from Cab dealerships and SEVNA repair facilities, loss of time, loss of pay, loss of use, inconvenience, commercial loss (including lost profits), towing charges, bus fares, Cab rental, service call charges, gasoline expenses, incidental charges such as telephone calls and facsimile transmissions, and expenses for lodging.

This disclaimer is independent of any failure of the essential purpose of any warranties provided to purchaser, and shall survive any determination that a warranty failed of its essential purpose.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

## Dealer Representations Excluded

The entire Limited Warranty provided by SEVNA is set forth herein. SEVNA will not be responsible for any additional representations or warranties made by any person or entity other than SEVNA, and SEVNA's obligations are solely as set forth in the terms and conditions of this Limited Warranty.

## Your Obligations

The retail purchaser is responsible for normal maintenance, as described in owner's manuals provided with the Cab. However, SEVNA will provide for minor adjustments, such as adjustments to interior or exterior doors and voids in seals, for the first ninety (90) days following delivery of the Cab to the original retail purchaser.

If an issue arises that you believe is covered by the Limited Warranty, you should contact an authorized SEVNA dealer and give the dealer sufficient information to resolve the matter. If an authorized SEVNA dealer is unable to resolve your issue, you should contact SEVNA directly, by mail at 29391 Old US Highway 33, Elkhart, Indiana 46516, or by phone at 574-564-5866.

It is your responsibility to schedule an appointment for repairs and to arrange for transportation of the Cab to and from the authorized SEVNA dealership or the SEVNA repair facility.

It is your responsibility to notify an authorized SEVNA dealership, or SEVNA, of any issue you believe to be covered by the Limited Warranty, in a timely manner. It is also your responsibility to take reasonable measures to protect the Cab from further damage due to any defect that arises.

If you believe that an issue has arisen with respect to the Cab that is not covered by this Limited Warranty but is covered by the warranty of another manufacturer, you should review the warranty and other materials provided to you by that manufacturer in order to determine the procedure to be followed in order to obtain warranty coverage under that manufacturer's warranty.

If you are unable to obtain contact information for that manufacturer, an authorized SEVNA dealer or SEVNA will supply that information to you.

## Statute of Limitations

No action may be brought against SEVNA for breach of this Limited Warranty, any applicable implied warranty, or for any other claim relating to the Cab, more than thirty (30) days after the expiration of a limited warranty period. In the event both warranty periods are relevant to any claim, the thirty (30) day period provided for herein shall begin to run, as to any particular component to which the claim relates, at the end of the limited warranty period for that particular component.
